DESCRIPTION OF THE COAT OF ARMS

‘Argent on a Mount issuant from the base Vert a Tiger passant proper, on a Chief Sable, a Pale Or, thereon, between two Elephants heads couped of the field, a lotus flower leaved and slipped of the third, together with the motto “கற்றனைத்தாரும் அறிவும் ஆற்றலும்” and “Doctrina Vim Promovet Insitam”

Accordingly in the margin of the Grant the Arms are shown with the following tints:-

‘the base Vert’	-	a light green
Tiger	-	yellow on white ground
Elephants	-	grey on black ground
Lotus	-	White flower, olive green leaves, on gold ground
Motto Scroll	-	edger red, black lettering

English Translation of the motto:

“Learning promotes (one’s)
natural (innate) talent.”
